LOCAL LAW NO. 1 OF 1972

A LOCAL LAW AMENDING LOCAL LAW NO. 12 OF 1970, IN RESPECT TO THE COMPEN-  
SATION OF CITY ENGINEER.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH,

NEW YORK.

SECTION 1A  
SECTION 2 OF LOCAL LAW NO. 12 OF 1970, IS HEREBY AMENDED TO READ AS  
FOLLOWS:

SECTION 1B

SECTION 3B 3 IS HEREBY AMENDED TO READ AS FOLLOWS FOR CITY ENGINEER:

THE THIRD THROUGH THE FIFTH COLUMN SHOWS THE AMOUNT TO BE RECEIVED UPON THE COMPLETION OF THE SECOND THROUGH THE FIFTH YEARS OF CONTINUOUS SERVICE WITH THE CITY OF PLATTSBURGH.

SECTION 1C

SECTION 3B 4 IS HEREBY AMENDED TO READ AS FOLLOWS FOR CITY ENGINEER:

THE SIXTH COLUMN SHOWS THE INCREMENT WHICH SHALL BE ADDED TO THE APPROPRIATE SALARY RATE OF THE CITY OFFICIAL UPON COMPLETION OF EACH ADDITIONAL MULTIPLE OF FIVE (5) YEARS OF CONTINUOUS SERVICE WITH THE CITY OF PLATTSBURGH.

SECTION 2 - SUPERSESSION

PROVISIONS OF ALL ACTS INCONSISTENT WITH THIS ACT ARE HEREBY SUPERSEDED.

SECTION 3 - TIME OF TAKING EFFECT

THIS ACT SHALL TAKE EFFECT ON AND AFTER May 1st, 1972, AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.
