LOCAL LAW NO. 2 OF 1971

ENTITLED: - AN ACT CREATING THE POSITION OF ASSESSOR PURSUANT TO ARTICLE 15A
OF THE REAL PROPERTY TAX LAW; AND FOR THE COMPENSATION, RATE OF
INCREASE, AND TIME OF TAKING EFFECT OF SUCH INCREASES FOR CERTAIN
CITY EMPLOYEE.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH,
NEW YORK, AS FOLLOWS:

SECTION I. THERE IS HEREBY CREATED THE CIVIL SERVICE POSITION OF
ASSESSOR IN THE CLASSIFIED CIVIL SERVICE OF THE CITY OF PLATTSBURGH, NEW YORK.

SECTION II. COMPENSATION OF EMPLOYEE: - ASSESSOR:

<u>A.</u> MINIMUM ANNUAL SALARY	2ND YR	MAXIMUM	INCREMENT	10 YRS	15 YRS	AFTER 20 YRS	25 YRS

B. THE INDIVIDUAL EMPLOYEES IN THE POSITION LISTED IN SUBDIVISION "A" ABOVE,
SHALL BE SUBJECT TO THE FOLLOWING CONDITIONS:

1. THE FIRST COLUMN SHOWS THE ENTRANCE OR MINIMUM COMPENSATION.
(A). UNDER SPECIAL CONDITIONS AND SUBJECT TO THE APPROVAL OF THE MAYOR,
NEW APPOINTMENTS CAN BE MADE AT AMOUNTS SHOWN UNDER COLUMN 2 OR
COLUMN 3 WHEN SUCH ACTION IS DETERMINED TO BE IN THE INTEREST OF
THE CITY.

2. COLUMN 2 SHOWS THE COMPENSATION TO WHICH THE EMPLOYEE IS ENTITLED TO UPON COMPLETION OF ONE (1) YEAR OF CONTINUOUS SERVICE WITH THE CITY OF PLATTSBURGH, NEW YORK.
3. THE THIRD COLUMN SHOWS THE MAXIMUM AMOUNT THE CITY OFFICIALS ARE ENTITLED TO UPON COMPLETION OF FIVE (5) YEARS OF CONTINUOUS SERVICE WITH THE CITY OF PLATTSBURGH, NEW YORK.
4. THE FOURTH COLUMN SHOWS THE INCREMENT WHICH SHALL BE ADDED TO THE APPROPRIATE SALARY RATE OF CITY OFFICIALS UPON COMPLETION OF EACH MULTIPLE OF FIVE (5) YEARS OF CONTINUOUS SERVICE WITH THE CITY OF PLATTSBURGH, AS SHOWN IN COLUMNS 5 AND 8.

SECTION III. SUPERSESSION.

PROVISIONS OF ALL ACTS INCONSISTENT WITH THIS ACT ARE HEREBY SUPERCEDED.

SECTION IV. TIME OF TAKING EFFECT.

THIS ACT SHALL BE IN EFFECT ON AND AFTER November 29, 1971, AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.

On roll call, Aldermen Burke, Branon, Akey and Ianelli voted in the affirmative; no one in the negative; (Aldermen Ryan and King being absent) CARRIED.
