Pursuant to sections 706.2 and 714 of the General Municipal Law the following described territory located in the Town of Plattsburgh, Clinton County, New York be and hereby is annexed to the City of Plattsburgh: That certain piece of parcel of land identified on the Town of Plattsburgh tax map as parcel no. 207.-2-5, being lands owned by the City of Plattsburgh and improved with an electric utility substation.
2. The annexed territory shall be located in ward 5 of the City of Plattsburgh.
3. The annexed territory shall be surveyed and mapped in accordance with the requirements of section 717 of the General Municipal Law.
4. This local law shall take effect upon approval by the Mayor and filing with the Secretary of State, but not sooner than March 1, 1994.


