 - " B. Term Limits. No person shall be eligible to be elected Mayor if from and after January 1, 1994 he shall have served eight consecutive years as Mayor of the City of Plattsburgh. No person shall be eligible to be elected Councilor if from and after January 1, 1994 he shall have served eight consecutive years as Councilor of the City of Plattsburgh. "
